1. Welcome – Mr Fisher

Mr. Fisher: Appreciates everyone's efforts in the virtual meetings and keeping the work going. Between an election and COVID it is an appropriate time for PIANC to start thinking about the fundamentals. There will be a recess as the pandemic ends and a new Administration, or second-term Administration, begins to set goals. This is a good time to figure out what our goals are.

2. Administrative Items – Manous

2.1. Agenda Acceptance

Manous – Suggests adding item 2.5 "rules and regulations for PIANC USA."

2.2. Acceptance of Minutes from 15 SEP meeting (Tab A)

Coles – Motion to accept.

Marino – Seconds the motion.

Manous – Are there any abstentions? None, Minutes approved.

2.3. Quarterly Budget Report (TAB B) – *Mantey*

Mantey – We used to have about 90% of our funds in a CD. We had 124K in checking and 32K in an uncashed check (from the Ports conference). The 124K in checking is due to the CD maturing and remaining in our checking account for now. The CD rate and interest rate in the checking account are the same right now so we are keeping the funds liquid. The commissioners passed a resolution at the last meeting to open an account at the State Department Federal Credit Union. We applied for membership at the FCU which takes 30 days. We plan on adding Waltemire and Manous to the BB&T account. Mantey has been filling out the paperwork for this process. We plan on depositing the 32K check at BB&T while we wait on the FCU approval. For more details, see the budget report. Dues received during the first 9 months of the year are greater than what we had last year. Estimating that we are going to make about 36K this year.

Currently the promotional materials are saved there as we work to update. The updated work plan and action plans will also be saved in this location. There is also a public with meeting minutes from the last two meetings.

2.5. Rules and regulations for PIANC USA – *Manous*

Manous – These were last updated 5 years ago. Proposes that Manous and Waltemire review these rules and regulations and present edits to the group for discussion.

- 3. Introduction of US Principal Representatives to the Commissions *Manous*
 - 3.1. Role of the US principal reps at board meetings

Manous – PIANC prides itself on being a technical organization. The working groups produce products that are of benefit to navigation communities around the world. The Board has discussed the benefits from including the principal reps in quarterly meetings PIANC-USA Board meetings to facilitate communication. Commissioners to serve as liaisons to the PIANC Commissions have been identified as follows.

RecCom – Jessica McIntyre

InCom – Ron Coles

MarCom – Jim Marino

EnviCom - Jim Walker

Pansic – Supports anything we can do to improve the communication linkage between the commissioners and the technical commissions. This communication has waned in recent years, but two-way communication is needed. We need to be more engaged with the membership through the engagement of the principal reps to the commissions. New working groups are proposed, but building teams lags. We want to make sure the US is well represented on the working groups. Will look to the principal reps to help with this communication and engagement.

3.2. Principal Representatives introductions

Suedel – Principal rep to EnviCom. Member of PIANC for several years. Actively engaged in numerous working groups through membership or mentorship. Pays close attention to engaging the other commissions and establishing working groups that can collaborate between multiple commissions. Army Corps of Engineers, Vicksburg Mississippi. Also agrees with this coordination effort.

Sanchez – Principal rep for InCom. PIANC member for 18 years. Member of multiple WGs. Originally started as a researcher, then as a lab director. Agrees that this is a

good idea. There has been a disconnect in the past between the commissions and the involvement of PIANC USA. This will help bridge that communication gap.

Armbruster – Principal rep on RecCom for a few years. There are several RecCom groups that are looking for expertise and trying to expand on their efforts. I see opportunities for collaboration in those areas. VP of waterfront engineering for Taylor Engineering. Navigation and recreational facility oversight.

Heffron – Co-lead of RecCom. Agrees that this is a good effort forward to include the principal reps in the meetings.

3.3. PIANC USA Webinars

Manous – The goal is to have 1 webinar a quarter focused on a specific technical commission. We want to use this to disseminate information to the membership.

Almodovar – MarCom would have been the last one for this quarter, and the only one without a session this year. Referenced the document on webinar guidelines and suggested MarCom host the next webinar.

Manous – Would like to invite the principal reps to engage in this process of planning and coordinating the quarterly webinars.

Heffron – We discussed this at the MarCom meeting a few weeks ago. The preparation of a PowerPoint with the completion of a report is now becoming a requirement for the chair of the group to put together. This PowerPoint can be repurposed as a webinar tool. The big issue from the principal perspective is that a lot of the administrative work should not fall on the principal rep.

Almodovar – Part of the goal is to increase involvement with sister organizations and new membership through their attendance of these webinars.

Manous – Is there a volunteer for the first quarter of the calendar year for the webinar? *No volunteers at this time.* (See item 12 for additional discussion. Heffron will serve as lead for MarCom webinar in first quarter.

4. PIANC ExCom Report (TAB C) – Pansic

Pansic – There is a lot of discussion at the ExCom level about meetings and the value of face-to-face meetings. A lot of the meetings are being postponed or being reconfigured as virtual only or hybrid events. A regional event for Asia-Pacific group at the beginning of December in Australia is now a hybrid event. AGA in Bristol for this year is postponed to May of 2021. It will be a two-day virtual event with two, four-hour sessions. Until there is progress with travel, we will have to shift our focus away from inperson events and move to virtual events. VP for ExCom is up for renewal and chairman of CoCom. We want to make sure we participate in nominating and voting for who should fill these roles.

Schmeltz – Neil's mandate as the VP is up for renewal. He will most likely roll into his next term. At the ExCom level you can have two, four-year terms in a position then you vacate the position. Typically, if the group is happy with the work you are doing, they will encourage you to continue into the next term.

Walker – Are there any updates on the copyright issue?

Pansic – They have updated the agreement to reflect the position of USACE participants and people who work for the US government. People online are trying to catch copyright infringement. We do not want this to be a deterrent for people being involved. Many of the people who participate in working groups and provide images and items for the reports do not have the time to be experts in copyright law as well.

Manous – The initial issue is whether an individual can commit the government to the liability of a work that is not part of the jurisdiction of the government. The direction forward appears to be that the USACE will have participants sign a form that clarifies their role(s) reference copyright liability and there is an individual liability when signing the PIANC copyright release. In the past this has not been an option from the government perspective because the court decides who is held responsible. Manous has requested an update from the USACE Office of Counsel before Thanksgiving. The resolution is most likely a requirement for USACE employees sign a USACE document verifying their personal liability before signing the PIANC copyright document.

Manous – This is an annual report where we put together articles of what we've done this year.

Manous – Requesting articles and updates from everyone prior to Christmas. **Double** check on the deadline for this.

- 6. PIANC Leadership Vacancies Waltemire
 - 6.1. Nominations for CoCom Chairman Due 31 DEC (TAB F)

Waltemire - Currently Ed Schmeltz is a co-chair.

6.2. Nominations for Vice – President of ExCom Due 31 DEC (TAB G)

Waltemire – There are 4 vice-presidents on ExCom. Currently Nick Pansick serves as one of them. Neil Lawson's term (Australia) is ending and they are looking for nominations.

6.3. Process for sending out call for nominations

Waltemire – What has the process been in the past? Has this been distributed to all members as a call for nominations or do the commissioners nominate internally? Nominations are due by 31 DEC. Need to move quickly due to the holidays.

Schmeltz – We need to find someone who is willing to do it. We want to make sure they can support the level of activities. A fair bit of it is the travel that is involved. Typically, the VP roles are filled by people who are physically in those regions. Neil's position would either be continued or would be filled by someone else from his region.

Manous – We need to vet the nominations. This coordination will take place around the 20th of December. Members of the board or anyone else should contact the perspective person for nomination directly and forward the name to Waltemire. She will collect the names and we will share that with the board.

7. Membership Survey (TAB H) – Almodovar/ McIntyre

Almodovar – This is part of objective 2 of the work plan. The idea initially was to gather input on ideas for trainings, events, webinars etc. This would be in addition to the quarterly webinars that we are already working on. We should figure out the topics that are of most interest to the members for us to put together events. We want to determine the leadership potential of the members of PIANC, so some questions relate to their willingness to lead. The plan would be to put this on the website and have everyone fill it out. Once we survey the existing members, then we can add it to the registration form

when people become members of PIANC so we can expand the database. We can add a question about working group topics. There could be a link to the website that defines what working groups are so new members are informed.

Manous – This is an opportunity for us to discover what other opportunities PIANC can offer to add value. We could expand the questions on the survey to figure out what type of virtual events people are looking for such as how many a year, how long would the ideal webinar be etc. We can also receive input on the technical content and the manner of how they would participate in it. Suggests moving the survey in a broader direction.

Sanchez – Would be curious about the questions to use in the survey for how relevant it would be.

Suedel – Agrees with this idea and expanding the survey to figure out topic areas that are relevant to all commissions. Willing to fill it out and send it to other EnviCom members for their feedback.

Armbruster – The challenge would be how responsive members would be, and how to make it broad enough to capture the interest but not so long that people do not respond.

Almodovar – Thought the question about topic ideas could be open ended so it does not make it too specific and make people think that we are only focused on certain topics area. Suggests that the principal representatives put together a list of topics relevant to their commission to include in the survey about working group topic areas.

Manous – Will work with Waltemire on how we can distribute this. Almodovar and Jessica will send the updated version. Waltemire will compile additional working group topic areas and forward to Almodovar for final edits prior to the December meeting.

8. PIANC America Conference – *Creech*

Creech – Nothing new to report. We are tracking potentially 2023 for the PIANC America conference. Consensus within the steering committee for PIANC Americas is to wait for more stability before deciding on a date.

Manous – There was a plan to have a conference in December 2020 focused on Central and South America to bring together new groups and parties with a common America's focus. Creech has taken the lead in coordinating this group. Original location would have been in Miami FL.

9. Port's 22 Planning Meeting (TAB I) – *Manous*

Manous – Has attended the planning meetings. PIANC USA has been partnering with ASCE COPRI on their tri-annual PORTS conference. Next event scheduled for Sep 2022 in Honolulu, Hi. Deadlines on call for papers, when abstracts are due, etc. can be found in the attachment. They are still trying to decide if 2022 is a feasible date.

10. Marine Board Virtual Summit - Walker

10.1. 09 NOV 10, 10 am – 4:30 pm ET

10.2. Jim Walker Plans to attend

Walker – The main issue is related to USACE funding. Funding has been cut in the past for USACE participation with the TRB but USACE has continued participation with the Marine Board. This year both the TRB and Marine Board participation fees from USACE have been funded. Will be talking with Scott Brotemarkle and Kevin Knight on opportunities for PIANC-USA engagement. The Marine Board provides reports and set standards. Scott Brotemarkle serves as Program Director for the Marine Board as an employee of the National Academies. Will see if Scott can join a PIANC-USA meeting at some point to provide an overview. CMTS structure/engagement is more an affiliation of federal agencies, whereas the Marine Board has greater inclusion of academia and research topics.

Manous – Plans on participating for part of the virtual summit. National Academies of the US have under them 1 organization called the Transportation Research Board. Under the TRB there are several sub-elements. One is the Marine board. The TRB meets annually in January and is the largest transportation conference in the world. The marine board focuses on inland and oceanic navigation. Suggests an overview for this group as to what the Marine Board does.

Heffron – The Marine Board meeting is an outstanding venue to present the products from the working groups. As well as the TRB annual meeting. You are also exposing PIANC in general which could increase membership.

11. PIANC America Update – *Creech*

Creech – PIANC America initiative was born out of conversations from Smart Rivers conferences in 2015. Since 2015 there have been two Smart Rivers, COPEDEC, World Congress etc. Because of those conferences in the Americas, there has not been a need to establish the PIANC Americas conference but now there are no events scheduled in the near future. The goal is to organize events relevant to the national sections and qualifying members in the Americas and work with countries in the Americas who want to become national sections. We held three meetings with key leaders from these countries. Nine to ten countries have been represented so far at these meetings. The last meeting focused on the goals of this larger group. The US and

Argentina are the main national sections that plan events. The national section in Colombia is growing. Within this context, the group recognizes that representation in the working groups from members in the Americas tends to be limited. It is challenging for the qualifying members to stay up to date on the happenings in the working groups and PIANC in general due to lack of that involvement. The focus will be to move towards virtual events rather than the in-person PIANC Americas event. There are other regional groups as well and we want to have a webpage developed for PIANC Americas similar to those other regional groups so people can stay up to date.

12. PIANC USA Board Meeting and Annual Meeting – Manous

Manous – The proposal is to have an annual meeting where the principal reps can provide updates on their commissions to the membership (15 minutes each). We will also hand out certificates to PIANC members who participate in the publication of working group reports. Would also propose a keynote speaker such as Nick Pansic from ExCom to provide an update on the direction of PIANC. Include a panel discussion at the end to receive input from the membership. The morning would be a normal quarterly commissioners call. Should this be open to the entire membership or just those who normally participate in our quarterly calls? Manous suggests opening it up to everyone.

Almodovar – Agrees that it should be open to all members so they can have an update on what we have been working. Concerned about the date with COVID. Concerned about the virtual element with presenting the certificates that it would not be as impactful.

Schmeltz – We had annual meetings for PIANC at one time. Conceptually it is a good idea. If there are certain issues that are sensitive to the entire membership, we could have a short executive session prior to opening it up. In the past, a YP who one a paper contest presented.

Marino – In the past it has come down to timing and making it in conjunction with another event already scheduled. It is challenging for the leaders from the ASA's office to attend the entire event so that could warrant a smaller executive session.

Walker – The national dredging meeting is now in the June/July time frame. This could be a logical link up and would draw USACE participation. TRB could be another option. January will be tied up with inaugurations, new members of congress, prep for Presidents' budget etc. That may present additional challenges for the ASA's office.

Pansic – Can we still offer a virtual meeting/event of some sort in the first quarter that is broader and not focused specifically on a commission?

Walker – We could have pre-recorded presentations and give people an opportunity to view them then attend a panel discussion to ask questions.

Almodovar – Topic could be the situation of the navigation industry in the US as a result of the pandemic and discuss response options.

Manous – Is there agreement that the annual meeting should be aligned with the dredging meeting in June? When you tag this onto another virtual event, people need a break. Benefit of having it earlier is that we will increase the connection sooner.

Heffron – Concerned that if you are trying to tack on this meeting to another virtual meeting it will be challenging for people in various time zones.

Pansic – In favor of something sooner rather than later since both now and June would be virtual.

Schmeltz – January seems to early from a planning perspective. Suggests April.

Almodovar – Suggests April/May so the change in leadership will have already occurred. Once we have established this annual meeting, we can rotate the meeting between the time zones.

Manous - Summary of discussion

- Decision is for an Annual meeting to be held in Apr 2021.
- First calendar year PIANC-USA Board of Commissioners' meeting will be held in Feb 2021
- Additional consideration will be given by the PIANC-USA staff on alternative virtual events for the first quarter.
- **Heffron with MarCom** will help develop content for the PIANC-USA webinar for the **first quarter of the CY**.

Fisher – We probably will not have an ASA(CW) by January but we may have a hold over ASA(CW) by April/May.
