PIANC is the global organisation providing guidance and technical advice for a sustainable waterborne transport infrastructure to ports, marinas and waterways. ABSTRACTS

PIANC invites you to contribute to the programme by submitting an abstract to be considered for an oral or poster presentation at the congress.

The theme of the Congress is: "Future Ready Waterborne Transport – Unlocking Africa"

The Congress will include Streams that focus on:

- Overcoming challenges in waterborne transport in Africa
- Dredging (in the framework of port and navigation projects)
- Logistics & Infrastructure
- Ports
- Marinas and small craft harbours
- Environment

Papers and posters should present systems, processes, and practices in use and in development spheres within the general congress theme and sub-themes articulated above.



Only abstracts adhering to the following requirements will be considered:

Abstracts outline:

- Abstract title
- Author name(s) and institutions
- Abstract body limited to one (1) page

Brand names may not be used in abstract titles and are limited to one reference within the body.

A structured, concise, and factual abstract – 1000 words maximum - is required. The abstract should be written in the provided font (Arial 11pt) and usually comprises 1 to 3 paragraphs of text with no headings, bullets, or other special formatting. No figures should be included. An abstract for the 35th PIANC World Congress outlines a scientific contribution related to the theme and sub-themes of the congress. The abstract should be written in the English language.



The abstract should contain, as a minimum, the following:

Context: What is the focus, context, or scope of the

research/work/case study?

Objective: State the objective or scientific question that

the research aims to answer.

Method: Details on the method of research, i.e., field/

laboratory tests, experimental setup,

instrumentation, or numerical modelling.

Results: Typical or general results from the study/

investigation/case study.

Conclusions: A brief statement giving the most important

outcome(s) of the work.

An abstract is often presented separately from the article, so it must be able to stand alone. For this reason, references should be avoided. Also, non-standard or uncommon abbreviations should be avoided, but if essential they must be defined at their first mention in the abstract itself. The abstract should also not contain any brand/product/company names and should be free of any commercial advertising.



ABSTRACT REVIEW

All abstracts will be reviewed by the Technical Committee. Abstracts will be accepted or rejected based on its review score and at the discretion of the Technical Committee.

The closing date for submissions is 20 July 2023. If your abstract is accepted for an oral or poster presentation you will be notified by 01 Sept 2023. A full paper will be required by 06 Nov 2023.
